On Approval of the Comprehensive National Programme for Support, Social Adaptation and Reintegration of Citizens of Ukraine Internally Displaced from the Temporarily Occupied Territory of Ukraine and Anti-Terrorist Operation Conduct Area to Other Regions of Ukraine for the period until 2017

Cabinet of Ministers of Ukraine resolves:

1. To approve the Comprehensive National Programme for Support, Social Adaptation and Reintegration of Citizens of Ukraine Internally Displaced from the Temporarily Occupied Territory of Ukraine and Regions of Anti-Terrorist Operation to Other Regions of Ukraine for the period until 2017 (hereinafter — the Programme), which is annexed hereto.

2. The Ministry of Social Policy shall ensure the coordination and implementation of the Programme and inform the Cabinet of Ministers of Ukraine on implementation of the Programme measures quarterly, until the 20th day of the month following the reporting one.

3. The Ministries, other central executive authorities, regional and Kyiv state administrations shall quarterly, until the 5th day of the month following the reporting one to provide Ministry of Social Policy with information on implementation of the Programme.

The Comprehensive National Programme for Support, Social Adaptation and Reintegration of Citizens of Ukraine Internally Displaced from the Temporarily Occupied Territory of Ukraine and Anti-Terrorist Operation Conduct Area to Other Regions of Ukraine for the period until 2017

I. The Aim of the Programme

The aim of the Programme is to solve basic problems of citizens of Ukraine internally displaced from the temporarily occupied territory of Ukraine and antiterrorist operation conduct area to other regions of Ukraine (hereinafter — internally displaced persons, IDPs) and to reduce social tension among them and in society; to promote social integration and adaptation of such persons at a new place of residence; to assist in ensuring the proper living conditions, rights and realization of the potential; to provide social, medical, psychological and material support; to create conditions for the payment of compensation of financial and moral damages; to create favourable conditions for the voluntary return to the previous place of residence (provided the actual full cessation of hostilities in areas where public authorities temporarily do not exercise their power).

II. Ways and Methods of Solving the Problem

Results of the analysis of the situation with IDPs have shown the presence of a complex of the following problems that require urgent solution:

Lack of:

financial resources for life support;

precise mechanism and eligibility criteria for IDPs social support according to their material conditions and social status;

information on amount of damages (property damage) caused to displaced persons in course of hostilities and the mechanism of their compensation;

weak mechanisms of IDPs employment, lack of information about employment opportunities;

many IDPs have psycho-physiological traumata, but there is not a corresponding program of medical and social assistance for IDPs;

The aim of the Programme can be achieved based on:

compliance with the principles of subsidiarity, social justice, transparency and impartiality, mutual responsibility, mutual respect and understanding;

observance of rights and guarantees of citizens, including the right to work, and promotion of the rational use of labour potential of IDPs;

observance of the constitutional rights and guarantees of citizens to housing and a land plot;

promotion of the creation of a system and mechanisms for mutual assistance and self-organization of IDPs;

cooperation with the social partners and the representatives of private sector of the economy;

creation of favourable conditions for the voluntary return of IDPs to original places of residence or integration at a new place of residence.

The problem is being solved by the following:

legal support — provision of legal assistance, rise of legal literacy of IDPs, improvement of the laws and development of clear instructions for their implementation, development of remedies for rights protection and provision of compensation for IDPs' financial and moral damages;

socio-economic support — validity of guarantees for social welfare and protection of IDPs, provision of financial support to ensure the normal level of life and prevent poverty, promotion of job creation, employment and self-employment of IDPs, ensuring of accessibility of educational services, assistance for construction of permanent, temporary and social housing, support for statutory activities of public associations of IDPs;

health care support — validity of guarantees for public health care, provision of comprehensive medical services in places of compact settlement of IDPs, provision of psycho-sociological assistance to persons affected by hostilities, creation of conditions for preservation of health of IDPs in the new conditions of life;

transport support — provision of transportation services needed for evacuation of civilians from the zone of hostilities and for other needs of IDPs;

welfare support — creation of the adequate communal and household conditions for life of IDPs, ensuring of the availability of household and social infrastructure facilities;

cultural and patriotic educational support — promotion of the preservation of traditional culture, ensuring of non-conflict integration of national culture and cultural traditions of the population of the territories of displacement, education and development of patriotic feelings, promotion of spiritual development of IDPs;

organizational and information support — creation of the system of collection of information on the conditions and needs of IDPs, ensuring of its systematization, analysis and publication, the involvement of civil society institutions for the continuous independent monitoring, generalisation, analysis and control over implementation and results of the Programme.

III. Tasks and Measures of the Programme

Tasks and actions of the implementation of the Program are listed in the annex. The implementation of specified ways and measures for integration, social adaptation and protection requires:

timely coverage in the mass media procedures of provision of different types of assistance, privilege and compensations to IDPs;

organization and carrying out of meetings with IDPs, groups of activists and representatives of public associations to identify the problems of IDPs;

completion of the Consolidated information database on IDPs with consideration of their needs and intentions;

support of projects aimed at solving the problems of IDPs, including the construction of permanent, temporary and social housing;

creation of preconditions for compensation of IDPs' property (material) and moral damages incurred as a result of hostilities and a temporary occupation of the part of territory of Ukraine on the basis of evaluation of losses conducted on a single and transparent methodology;

permanent independent (public) monitoring of the implementation of the Programme, as well as current (interim) and final results of the Programme realization with the involvement of interested civil society institutions.

IV. Expected Results, the Programme Effectiveness

The Programme effectiveness is evaluated by the following criteria:

the volume of expenditures from the state budget for social assistance to IDPs; the volume of expenditures from the state budget for compensation of IDPs' property (material) and moral damages;

- the volume of investments into the housing for IDPs;

- the volume of raised donor funds (assistance) to address the problems of IDPs;

indicators of the product:

the number of IDPs who have received appropriate service, assistance;

the number of proposed projects of public associations to solve the problems of IDPs, the share of completed projects;

the number of realized measures for provision of support and services to IDPs;

the number of implemented joint projects along with international organizations regarding the assistance to IDPs;

- the number of IDPs who have received housing, the area of received housing;

indicators of effectiveness:

average amount of allowance per person/family; average received housing area per person; the cost per square meter of housing received by IDPs; - the number of IDPs who have received compensation payments for their property (material) and moral damages;

quality indicators:

the percentage of IDPs provided with respective social services, of their total number;

the percentage of IDPs who have received compensation payments for their property (material) and moral damages, of their total number;

the percentage of IDPs who have received housing, of their total number;

the percentage of IDPs who have received social services of poor quality, of the total number of IDPs who have received services.

The implementation of the Programme will allow:

to ensure social, physical, medical, psycho-physiological and material support to IDPs;

to reduce social tension in society and to ensure a non-conflict integration of IDPs in the society at the state and local levels;

to ensure the integration of IDPs in territorial communities in the event of their decision to stay at the new place of residence;

to facilitate the voluntary return of IDPs to previous places of residence after the actual full cessation of hostilities and regaining of control over the occupied territories of Ukraine where public authorities temporarily do not exercise their powers.

V. Volumes and Sources of the Programme Financing

Measures for implementation of the Programme shall be carried out from the state budget of Ukraine and other resources envisaged by the legislation.
