

Extradition (Kiribati) Regulations 2010¹

I, QUENTIN BRYCE, Governor-General of the Commonwealth of Australia, acting with the advice of the Federal Executive Council, make the following Regulations under the *Extradition Act 1988*.

1 Name of Regulations

These Regulations are the *Extradition (Kiribati) Regulations* 2010.

2 Commencement

These Regulations commence on the day after they are registered.

3 Definition

In these Regulations: *Act* means the *Extradition Act 1988*.

4 Extradition country

For the definition of *extradition country* in section 5 of the Act, Kiribati is declared to be an extradition country.

5 Offences that are not political offences

An offence mentioned in paragraph (d) of the definition of *political offence* in section 5 of the Act is not a political offence in relation to Kiribati.

6 Modification of Act — application to Kiribati

For section 11 of the Act, the Act applies in relation to Kiribati as if a reference to 45 days in paragraph 17 (2) (a) of the Act were a reference to 60 days.
