




Recent security situation in North Waziristan Agency (NWA) in Pakistan has led to the displacement of thousands of people to surrounding districts in Paktika and Khost province in Afghanistan. Initial registration figures, as of 29 June, indicate a total of 95,411 persons (14,615 families). Approximately 777 Afghans have also crossed the border from NWA and are living in several districts in Khost province.

Food, WASH, shelter and non-food items are the immediate priority needs. Humanitarian partners currently providing assistance in the region include AADA, APA/UNHCR, ARCS, ASR/WFP, HNI-TPO, IMC, IOM, IRC, MEHR, MSF, UNHCR, UNICEF, and WHO.


