List of themes in relation to the combined nineteenth to twenty-second periodic reports of Costa Rica (CERD/C/CRI/19-22)

Note by the Country Rapporteur

The Committee on the Elimination of Racial Discrimination decided at its seventy-sixth session (A/65/18, para. 85) that the Country Rapporteur would send to the State party concerned a short list of themes with a view to guiding and focusing the dialogue between the State party's delegation and the Committee during the consideration of the State party's report. This document contains a list of such themes. This is not an exhaustive list; other issues may also be raised in the course of the dialogue. No written replies are required.

Statistics on the demographic make-up of the Costa Rican population

Further information on the results of the 2011 census and disaggregated data on persons who self-identify as being indigenous or of African descent (CERD/C/CRI/19-22, paras. 23 to 40).

The legal, institutional and public policy framework for combating racial discrimination (arts. 2, 4, 6 and 7)

- (a) Further information on the measures taken to align national legislation with article 4 of the Convention (CERD/C/CRI/19-22, paras. 59 to 62);
- (b) Information on the specific changes made to public policies for combating structural racial discrimination as a result of the 2011 census, including information on the participation of Afro-descendant and indigenous persons in the country's decisionmaking bodies (CERD/C/CRI/19-22, paras. 23 to 40);
- (c) Information on the specific measures established in the national policy for a society free from racism, racial discrimination and xenophobia. Information on resources allocated for the policy's implementation, the State bodies that are applying the policy and the impact it has had (CERD/C/CRI/19-22, paras. 13 to 19);





- (d) Information on the participation of civil society, and, in particular, of representatives of the migrant, Afro-descendant and indigenous populations, in the activities of the Inter-Agency Commission for the Monitoring and Implementation of International Human Rights Obligations (CERD/C/CRI/19-22, paras. 8 to 11);
- (e) Information on investigations into offences of racial discrimination, the number of cases brought and convictions served, and the compensation obtained by victims. Information on the State party's response to xenophobic and racist attacks on Afro-descendant deputies;

- (g) Information on measures adopted to provide protection for human rights defenders, particularly human rights defenders of indigenous or African descent.
