FILM DIRECTOR JAILED FOR 'INSULTING OFFICIAL'

Film director lnes Ben Othman has been sentenced to two months in prison for insulting a public official.

Ines Ben Othman was sentenced to two months' imprisonment on 7 January, for "verbally insulting a public official while carrying out their duties" under Article 125 of the Tunisian Penal Code. Her lawyers claimed that while they were allowed to present their defence in court, they felt the judges showed no real interest in listening. They plan to appeal the court's decision.

Ines Ben Othman had been detained on 19 December 2014 after going to Ariana police station in the suburbs of Tunis to complain about months of harassment by the deputy head of the station on Facebook. Instead, following an argument with the deputy head, she was charged and detained.

Amnesty International believes that a prison sentence for insulting an official is a disproportionate restriction on freedom of expression and that charges of insult or defamation should be treated as a matter for civil litigation. The organization has repeatedly criticized the Tunisian authorities' use of such charges against government critics, journalists, bloggers and artists and has called on the them to review Tunisian laws, including the Penal Code, that stifle freedom of expression.

- Urging the Tunisian authorities to quash Ines Ben Othman's conviction;
- Calling on them to release Ines Ben Othman;
- Calling on them to review and reform Tunisian laws that are used to arbitrarily restrict freedom of expression.

FILM DIRECTOR JAILED FOR 'INSULTING OFFICIAL'

Ines Ben Othman, who is Secretary General of the Union for Cinema and Audiovisual Technicians within the General Union of Tunisian Workers (UGTT), was charged with "verbally insulting a public official while carrying out their duties" under Article 125 of the Penal Code, which carries a punishment of one year's imprisonment and a fine of 120 Tunisian Dinar (US\$64). Her lawyers' suspect that she has been targeted because of her activism and that of her fiancé, Walid Zarrouk, a former prison officer and founder of the organization Mourakeb, which monitors police compliance with human rights.

The right to freedom of expression, enshrined in Article 31 of Tunisia's new Constitution and in Article 19 of the International Covenant on Civil and Political Rights (ICCPR), to which Tunisia is a state party, includes the right to publicly criticize officials and institutions. According to the UN Human Rights Committee, the body which monitors compliance with the ICCPR, public figures and institutions should tolerate a greater degree of criticism than people generally. This means that criminal or other laws which provide special protection against criticism for public officials are not consistent with respect for freedom of expression.
