EXPLANATORY NOTE

SAN MARINO / GENERAL OVERVIEW

According to information provided by the Ministry of Justice, there is little legislation on racial discrimination in the Republic of San Marino. This can be explained by the State's characteristics and by the absence of any visible manifestations of racism in its territory so far.

It is probably for that reason that Art. 4 of the "Declaration of the Rights of Citizens and of the Fundamental Principles of the Legal System of San Marino", which was approved in 1975 by ordinary law (San Marino has no constitution) and which affirms the principle of equality before the law, does not refer specifically to racial or ethnic discrimination. San Marino has not ratified the UN International Convention of 1966.

It should be noted, however, that certain civil and administrative provisions governing specific areas forbid racial discrimination (see the tables).
