Zimbabwe – ZWE39467 – Police/military camps in Braeside – Treatment of Seventh Day Adventists 24 November 2011

1. Is/was there a ZANU-PF military campsite at Braeside, Harare?

No sources were located indicating the presence of a ZANU-PF or a Zimbabwean military campsite at Braeside, Harare. Reports were found, however, of a Zimbabwe Republic Police (ZRP) camp/police station in Braeside. Reports indicate that the police station is used to detain political prisoners with allegations that detainees are beaten during interrogations at the Braeside police station.

A report on *zwnews.com* (a London-based pro-democracy news service¹) indicates that a ZRP station, with members residing on site, is located at Braeside.² The report claims that this facility, and 12 other military and police stations/camps were moved into the electorate of Harare Central in an alleged attempt by ZANU-PF to increase its vote in that seat. A Google Map satellite image (see Photo 1) of the Braeside Police Station suggests that the "station' consists of a number of buildings.

Several reports from 2007 to 2009 indicate that Braeside Police Station has been used to hold anti-government dissidents who were arrested or detained for questioning. Two sources indicate that an office of the Central Intelligence Organisation (CIO), the Zimbabwean secret police, was located at Braeside. NGO and news reports also allege the use of torture and denial of food to detained activists held at Braeside.

• A 2009 New Zimbabwe (described by worldpress.org as an independent news service³) report claimed that an office of the CIO was located at Braeside Police Station.⁴ The report claimed an activist was moved (while covered in blankets) between Braeside Police Station and a nearby military camp in Seke Road (See photo 2 at the end of the response). No further reports were located to clarify the location of this military camp.



- A 2008 Amnesty International report referred to a claim made by a senior (un-named) Movement for Democratic Change (MDC) official that 14 female MDC members were denied access to food while being detained at Braeside Police Station.⁵
- In 2008 *The Zimbabwean* (an online news service based in South Africa and the UK) reported a claim by a Movement for Democratic Change (MDC) activist that he was tortured to the point where officers had to call for a doctor to assess his condition. The activist claimed to have been water-boarded while held at Braeside Police Station.
- A March 2007 *ZimOnline* (an "independent' online newspaper based in South Africa) story on the trial of a group of MDC officials reported that a female defendant suffered severe injuries following "savage assaults at the hands of crack commandos in police attire during her detention at Braeside police station."

3. Does the government of Zimbabwe discriminate against the Seventh Day Adventist Church and/or its members?

No references were found explicitly stating that the Zimbabwe Government discriminates against the SDA Church or its members. The 2010 US Department of State (USDOS) *International Religious Freedom Report (July-December)* notes that the SDA Church has a long history in Zimbabwe particularly in the building and operation of educational facilities from primary schools to universities. No information is provided in the USDOS report to indicate that the SDA Church or its members are discriminated against by the Zimbabwean Government or at a societal level. The SDA website indicates the church has 1,324 churches in Zimbabwe and 679,849 members (out of a total Zimbabwean population of approximately 12 million). ¹⁰

Two sources were located (one dated and one recent) containing quotes from individuals alleging that SDA members are discriminated against on the basis of a perceived link to the MDC. A 2002 article in *The Daily News* (described by worldpress.org as pro-opposition¹¹ but accused of being under the control of the CIO by another Zimbabwean news site¹²) quotes a source (who refused to be named citing security fears) as commenting that "members of the Seventh Day Adventist and the Zion Christian Church were ... attacked for being MDC ,apologists'." The report did not provide any details on the nature of these attacks, nor were other references located to verify the claim.

A May 2011 report in anti-government, British-based news site *The Zimbabwean* quoted MDC officials claiming that SDA members in Mutoko were prevented from hiring a local school to conduct their services. ¹⁴ The article claims the decision to ban the hiring came from "overzealous" local ZANU-PF supporters on the basis that some local SDA members were also MDC members. No independent sources were located to confirm the incident occurred or that the denial of public buildings such as schools to SDA congregations is an official policy.

In contrast to the above, reports from 2011 indicate that the Zimbabwe President, Robert Mugabe, has a favourable opinion of the SDA Church. These reports relate to the attendance of Mugabe at the wedding, held at an SDA church, of the daughter of Mugabe's farm manager. As part of the wedding ceremonies, Mugabe made a speech in which he praised

the SDA particularly for its stance against homosexuality, ¹⁶ and describing the SDA Church as having "the best music". ¹⁷ The *Zimbabwe Herald* noted that the SDA singing group (who sang at the wedding) has performed for the first family since the 1980s. 18 The Zimbabwe Herald in a different article reported that at the wedding, the SDA Church vice president for Southern Indian Ocean Division, Pastor Paminus Machamire, gave a speech praising Mugabe. 19


