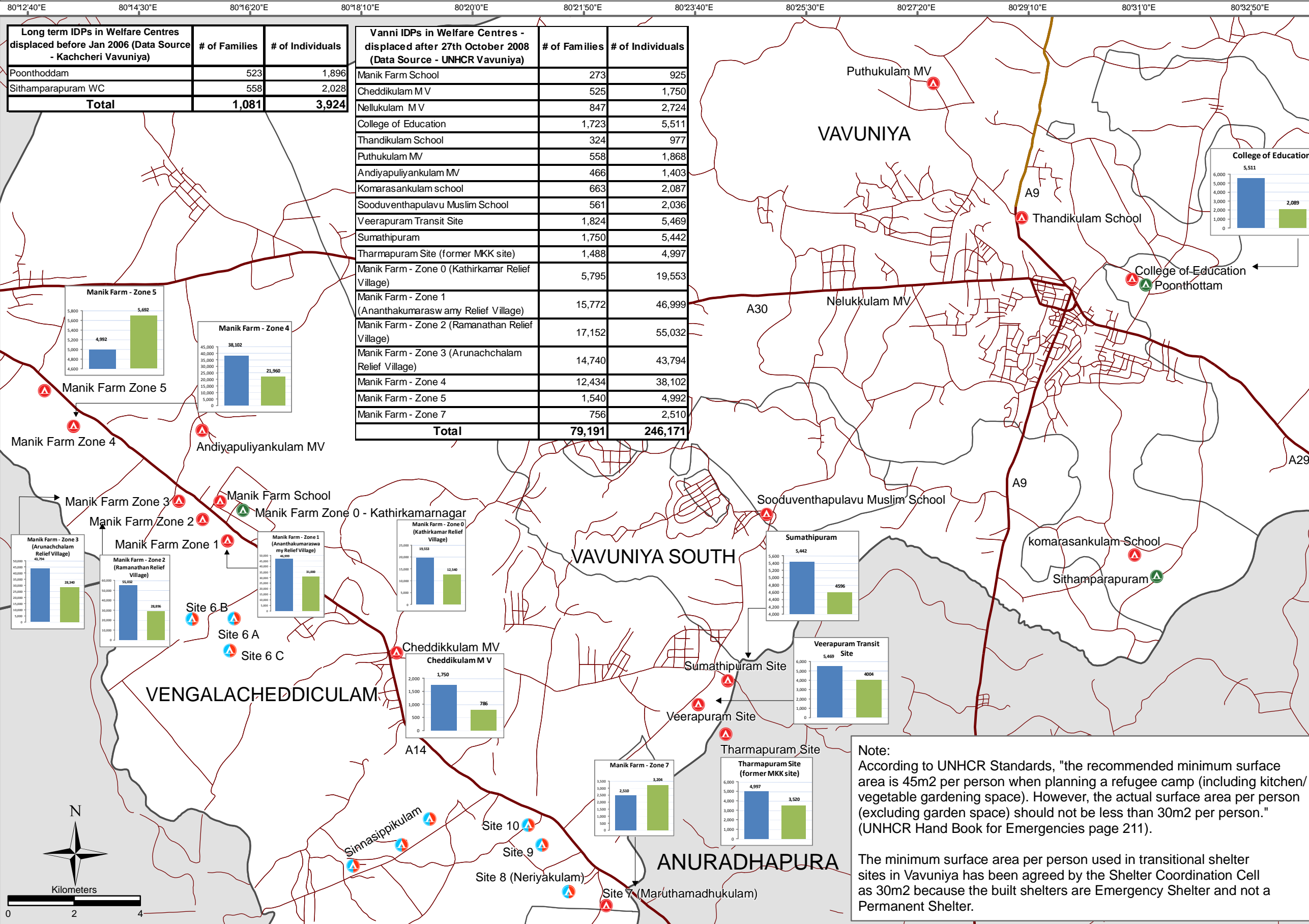


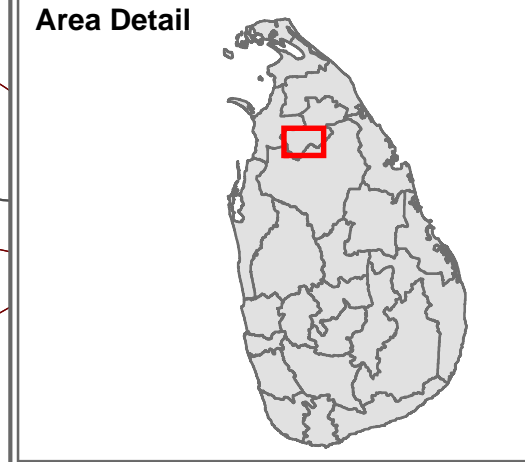

**Note:** According to UNHCR Standards, "the recommended minimum surface area is 45m2 per person when planning a refugee camp (including kitchen/vegetable gardening space). However, the actual surface area per person (excluding garden space) should not be less than 30m2 per person." (UNHCR Hand Book for Emergencies page 211).

The minimum surface area per person used in transitional shelter sites in Vavuniya has been agreed by the Shelter Coordination Cell as 30m2 because the built shelters are Emergency Shelter and not a Permanent Shelter.
