of the pledges are in Progress


and around

16% of pledges reported - close to 100 pledges - have now been fulfilled since the Global Refugee Forum.


Protection capacity topped the most fulfilled, followed closely by Education and Burden and responsibility sharing. Close to

#### **Matching: GRF Host Country Pledges**

#### East and Horn of Africa and Great Lakes region



At the Global Refugee Forum, stakeholders made pledges towards the objectives of the Global Compact on Refugees (GCR). Matching is the process of pairing pledges made by host countries to facilitate greater inclusion, protection, and support for people forced to flee with pledges made by donors to provide the financial, material, or technical support necessary for their implementation.

#### Djibouti

- Pledge number 1170. Responsibility sharing arrangements. Integrate refugees into Djibouti National Development Plan within its Vision 2035 framework
- Pledge number 1341. Education.
   Train and provide certification for refugee teachers and include their remuneration in the national budget

#### Ethiopia

- Pledge number 1258, Energy and infrastructure. Provide market-based and sustainable household and facilitybased energy solutions for three million people.
- 4. Pledge number 1315. Protection Capacity. Strengthening theGovernment of Ethiopia's Asylum. System and Social Protection Capacity

#### Kenya

- Pledge number 1309. Protection Capacity. Strengthening of institutions and community structures that manage asylum, deliver services, and provide security in refugee-hosting areas
- Pledge number 1312. Education: Strengthening support to refugee and hosting communityies education

#### Rwanda:

- 7. Pledge number 1104. Energy and infrastructure: Ensure sustainable use of natural resources by providing clean and renewable energy solutions in refugee and host community households, in order to discourage the use of firewood
- 8. Pledge number f124. Jobs and livelihoods: Expand tea plantations and improve necessary infrastructure that increase job opportunities for refugees and host communities; at least 30% of new job opportunities will target refugees

#### Tanzania

 Pledge number 1216 Education.
 The United Republic of Tanzania pledges to continue to work with UNHCR and other stakeholders to improve the quality of education for the refugees.

#### Uganda

 Pledge number 1248. Energy and infrastructure. Promote inclusive and sustainable management of natural resources and ecosystems



# 80% in progress



## **Southern Africa**

#### **Key progress**

- Accession to the 1954 and 1961 statelessness conventions is advanced in the Republic of Congo and the Democratic Republic of Congo
- Law reform in process in Madagascar, Lesotho, and Eswatini
- Well advanced data collection in Namibia, Eswatini, Angola, and Zimbabwe
- Strengthened birth registration in RoC and DRC
- Zambia, Malawi, Namibia progress towards inclusion in programs such as education, health, and livelihoods
- The International Association of Refugee and Migration
   Judges and the Southern African Legal Advocacy on Asylum
   & Migration are strengthening the capacity of legal practitioners

## **Southern Africa**

 Better implementation where UNHCR has presence and follows up with country authorities.

Most Birth registration pledges pending due to lack of funding and technical assistance.

 There is goodwill to implement in the region but there is need for funding and technical expertise.

 Of the possible matching opportunities previously identified, none was successful so far.

Need to set-up a regional platform of experience and expertise sharing. UNHCR calling on SADC to assist.






# **West and Central Africa**

#### 136 HLS and GRF pledges

- 17 pledges/136 (12,5 % with updates) including 2 fulfilled and 15 in progress
  - Inclusion in national systems/ development plans
  - Reform of asylum systems
  - Solutions
  - Energy (1 pledge in Chad)

#### Pledging entities

- 91% by States
- 5% by Regional Entities
- 2% by NGOs
- 1% by UN entities





## **West and Central Africa**

#### Constraints

- COVID 19 has prevented pledging entities from implementing their commitments
- Lack of funding: The lack of funding has been flagged by pledging entities as a major challenge during the December 2020 stocktaking event
- National leadership: Countries of the region in their large majority don't have national arrangements and/or national plans

#### Opportunities

- Strong commitment of regional entities: ECOWAS and CEMAC made pledges during and after the 2019 GRF pledges
- Regional approaches/strategies for Sahel and Lake Chad Basin Region with support from external actors

#### Next steps

- Foster a regional approach for the CAR situation by setting up a CAR support platform around the CAR situation
- Support ECOWAS for the adoption of the 4 year action plan on GCR operationalization
- Encourage pledging entities and especially States to adopt action plans and establish national arrangements



# West and Central Africa Way forward

- Message 1: Pledging entities in WCA need support to facilitate the implementation of their pledges
- Message 2: There is hope that the CAR support platform will help mobilize more attention around the forced displacement situation in CAR and support is required to facilitate reintegration in CAR and local solutions in asylum countries
- Message 3: Regional approaches are key in WCA to enhance the commitment of States especially regarding the adoption of national arrangements and national plans. ECOWAS and ECCAS are two major actors for the operationalization of the GCR in WCA
- Message 4: Pledging entities in WCA should consider Energy/ Environment as area of focus especially Sahel countries with the support of ECOWAS



#### **Unprecedented Displacement**

- 20% of global population of concern to UNHCR in the Americas, an increase of 50% since 2018 (end of 2020 - 18.3M)
- 5.6M refugees and migrants from Venezuela
- 549,000 refugees and asylum-seekers from NCA
- 108,000 refugees and asylum-seekers from Nicaragua
- 8.6M internally displaced persons
- Stateless persons

#### **Key Challenges**

- Increasing mixed and secondary movements
- Multiplicity of causes of forced displacement
- Socio-economic impact of COVID-19, competing priorities
- Increasing protection risks
- Long-term crisis and donors' fatigue




#### **Summary of Pledges:**

- 219 pledges from the Americas (14% of all GRF pledges)
- **States** (63%) and **NGOs** (13%) made up the bulk of pledges
- Majority of pledges focused on Protection
   Capacity (51), Statelessness (45) and Solutions (31)

#### **Progress to Date**

- Significant progress made in areas of protection capacity, education and jobs & livelihoods, as follows:
  - 23 pledges **fulfilled**
  - 74 in progress
  - 6 in **planning phase**
  - 131 did not yet report




# Asia and the Pacific Key progress and findings of stocktaking

- Important efforts to enhance refugee participation at pan-regional level and in Australia and Malaysia
- Progress towards resolving statelessness in Kyrgyzstan, the Philippines,
   Tajikistan, Thailand and Turkmenistan
- Refugee law and/or procedure reform in process in Australia, Indonesia, the Philippines, Republic of Korea, Thailand and Turkmenistan
- Improved inclusion of refugees in access to services (documentation, education and livelihoods) in progress or completed in Australia, Indonesia, Kazakhstan, New Zealand, the Philippines
- Partnership with the private sector contributing to self-reliance in Australia and Japan
- Strengthened birth registration in Kazakhstan, Kyrgyzstan, Tajikistan,
   Thailand and Turkmenistan
- Greater access to solutions and pathways achieved or in progress in Australia, Japan, the Philippines, Republic of Korea
- Enhanced support for returnees in Afghanistan and for Afghan refugees in Pakistan and Iran through the Support Platform for the Solutions Strategy for Afghan Refugees (SSAR)

# Asia and the Pacific Observations from regional stocktaking

- Correlation between progress on implementation and whole-of-society engagement in the development of pledges and follow-up process
- Outstanding needs for matching to facilitate implementation of important commitments
- Ongoing stocktaking has been useful to identify outstanding gaps in the region, whether in terms of thematic coverage (eg jobs & livelihoods), stakeholder groups (e.g. refugee-led organizations) or geographic diversity
- There remains work to do to "demystify" the GCR and GRF as concepts and processes to get wider range of stakeholders on board









#### PLEDGES FULFILLED BY THEMATIC AREAS



- Important headways made on prevention and reduction of statelessness: 22% pledges implemented (new accessions, legislative reforms, etc.)
- **Solutions**: Expansion of community sponsorship initiatives, humanitarian corridors...
- **Integration and inclusion**: challenged by COVID but adjustments to integration programmes
- Support to effective access to education
- Efforts to enhance right to work
- **Resettlement and complementary pathways:** More needs to be done
- **ACSG**: in progress good practice examples

# Middle East and North Africa

## **Key Messages**



Long cultural and historical legacy of asylum. Countries in the region continue to host millions of refugees and displaced persons, despite complex local and regional dynamics, protracted conflicts, and evolving socio-economic challenges and vulnerabilities exacerbated by COVID-19. Much support has been received over the years, yet, needs still outpace resources available. Longer-term solutions are required.

Regional Refugee and Resilience Plan pioneered meeting acute protection needs as well as resilience capacities of national authorities and host communities, adhering to the principle of "leave no one behind, and in line with the Global Compact on Refugees.

Reinforcing impactful development partnerships, including with the World Bank, linked to the Sustainable Development Goals, with a view to supporting sustained refugee inclusion in national development plans, social protection programs, and basic services, and wider opportunities for financing and resourcing.

Substantive progress on a whole of society approach in the region, including additional emphasis and resourcing for multi-stakeholder engagement, and accelerating local stakeholders participation in the design thinking, as well as operational management, of refugee situations.

GCR reiterated the need for continued solidarity and responsibility sharing and active identification of matching opportunities for the commitments and policy pledges made at the first GRF will be necessary to meaningfully demonstrate continued support to countries hosting large numbers of refugees.

# Snapshot of Regional Convenings in Follow-up to the GCR/GRF in MENA



First Mayor's Forum on Inclusive Cities, held in November 2020 for over 50 participants from cities and municipal authorities in North Africa, together with civil society partners in November 2020, including key sub-regional cityled convenings, fostering discussions with the World Bank on expected next steps;

First MENA GRF Multistakeholder Stock-taking and Second Annual MENA Civil Society Consultations in April 2021. 160 participants including multistakeholder partners from faith-based organisations, Islamic philanthropists, artists and cultural influencers, private sector, refugees, refugee-led organizations, INGOs, CSOs and NGOs. Partners provided updates on implementation of GRF pledges and discussed local, national, and regional level developments in relation to advancement of the multi-stakeholder "whole of society" approach.

Third Regional Academic Roundtable, this year on the theme of Climate Change and Displacement, co-convened with Columbia University Global Center in Amman in June. 200 academics, experts, policy makers, civil society partners, and private sector. First opportunity to unpack intersection between 2 contemporary mega trends and to identify joint research and resourcing;

Presentation to the General Secretariat and Member States of the League of Arab States Headquarters in Cairo on the GCR/GRF/HLOM on 8 June;

Regional briefing on GCR/GRF for delegates from governments, academics, and NGOs from the region at the International Institute of Humanitarian Law at San Remo on 21 June;



#### East and Horn of Africa and the Great Lakes (EHAGL)

- **IGAD Support Platform:** IGAD members states took stock of progress at "1<sup>st</sup> Regional Technical Experts' meeting on the Kampala Declaration on jobs, livelihood, and self-reliance for refugees, returnees, and host communities" (April)
- EHAGL Regional NGO Consultations: NGOs showcased GRF pledge implementation, challenges and needs for further support (June)
- Poverty Alleviation Coalition side event: to support 48,000 households extremely poor household to be self-reliant more funding is needed Funding level 23% (June)
- Internal regional stocktaking: desk-based review to ascertain support and coordination needs and implementation progress







### UNHCR GRF Highlights – EHAGL – Broadening the base

- **IGAD Support Platform:** showcases strong governmental and partner commitment for the **Sudan-South Sudan Solutions Initiative** to identify durable Solutions for IDPs and refugees and demonstrates the Nairobi Process in Action
- EU-ACP joint Parliamentary Assembly, co-led with Special Envoy for East & Horn: UNHCR highlighted progress vis-à-vis GRF partner and states pledges in Africa, discussed opportunities for engagement of the members of the European Parliamentarians, incl. potential mission to refugee hosting areas (May)
- **Country level progress:** considerable progress in developing national action plans, enhancing coordination between actors, pledge matching, e.g. Somalia Durable Solutions Strategy
- Regional Inclusion Exchange East Africa: establishes links between actors across humanitarian-development nexus supporting LH pledges (over 200 members)


